#### INTEGRATION POLICIES IN INDIVIDUAL CITIES - GDAŃSK, LUBLIN, CRACOW

Prior to the outbreak of war in Ukraine, the number of foreign nationals in Poland totalled slightly over 2 million, the majority residing in cities and metropolitan areas. The role of local governments in developing migration policies was gradually gaining importance. The Gdańsk Model of Integrating Immigrants adopted in 2016 on President Paweł Adamowicz's initiative had been the product of multiple urban public entities and civic communities working together. It was Poland's first local programme of integrating immigrants, recognised as a "challenge and opportunity for the economy" and public urban fabric.

For many years, Lublin had been the only Polish member city of the Intercultural Cities Programme of the Council of Europe, its concept based on boosting and supporting local community efforts to better use cultural diversity. Thanks to the Programme, Lublin developed foundations for deliberating migrant integration locally.

For nearly 6 years, Cracow has been implementing the "Open Cracow" programme to implement and deliver a policy of openness to representatives of national and ethnic minorities and foreign nationals. "Open Cracow" is a comprehensive and interdisciplinary approach to integration.

#### MONITORING URBAN DEVELOPMENT (KS - NORWAY, ZMP - POLAND)



Since 2000, APC and KS have separately been developing their own monitoring systems – with information publicly available on-line. The APC developed and maintained the Local Government Analysis System, which from 2020 was transformed – under EEA funded Local Development Program operated by the Ministry of Funds and Regional Policy – into the Local Development Monitor (it will be presented in the first part of the seminar - https://monitorrozwoju.pl/), while the KS has developed in cooperation with the Norwegian Statistical Office - "Local government monitoring system "(KOSTRA) (will be presented in the second part of the seminar - https://www.ssb.no/en/offentlig-sektor/kostra). Both systems support the diagnosis of the state of development of local government units (or the services provided), and make it possible to base strategic and operational planning on facts, not opinions. At the same time, they enable employees and local authorities, representatives of government administration as well as scientific circles and citizens to access the same verified data, which creates conditions for a more honest public discussion on development policy planning and its effects.

# HOSPITABLE POLAND 2022+ REPORT, RESULTS OF OPINION POLLS IN UKRAINIAN COMMUNITIES

#### Wise support for Poland and Poles assisting persons fleeing war in Ukraine

The inflow of millions of persons fleeing war in Ukraine in the wake of Russian aggression triggered an unprecedented grassroot movement of spontaneous community support, affording acclimatisation in Poland primarily to mothers and children leaving Ukraine while letting troops fighting for their country's survival know that their nearest and dearest are safe far away from the frontline.

Four main stakeholders forming a support network have been involved in offering assistance to Ukraine. They include non-governmental organisations, grassroot civil society initiatives, local governments and central government institutions. Outcomes of migration from Ukraine, Ukrainian citizens' integration, and development scenarios in assorted aspects of state operations have been discussed in the report "Hospitable Poland 2022+". In the course of the debate, we shall be presenting premises described in the document published on 21 June 2022.

The report was drafted by the WiseEuropa Foundation in collaboration with a large team of researchers, i.a. from the University of Warsaw, Warsaw School of Economics, and SWPS University of Social Sciences and Humanities. It lists proposals of activities making persons fleeing war in Ukraine part of the daily life of Polish society short-term on the one hand, and - on the other - allowing them full freedom in terms of the location they intend to live and function in once the war is over.

#### THE"HEAT AND ELECTRICITY FROM HOUSEHOLD WASTE" COVENANT

The condition of local district heating in multiple cities and towns requires urgent heating source modernisation, the sudden need for switching to alternative fuels conducive to rapid action. We have been struggling for years to increase the use of the "above-sieve" fraction as refuse-derived fuel (RDF) to generate heat and electricity. Legal changes will have to coincide with financing, and a related programme of supporting local projects. We invite cities and towns to join the coalition supporting these works, the team including the Chamber of Commerce Polish District Heating, National Chamber of Waste Management, National fund of Environmental Protection and Water Management, BOŚ (Bank for Environmental Protection), Polish Development Fund and technology suppliers.

# PREVENTING POLARISATION LOCALLY European Forum of Urban Safety (EFUS)



The EU-funded BRIDGE project was intended to raise awareness in local communities, and boost their capacity for reducing individual and collective susceptibility to attitude radicalisation, coinciding with preventing polarisation and mitigating its outcomes. The project was designed in particular to strengthen local tools of identifying and governing polarisation, assist local authorities in drafting activities intended to prevent tensions and social disquiet trends, promote local community- and co-operation-based initiatives, and foster the concept of a meeting of European representatives of local governments and experts proposing to handle polarisation at the local level.

The EFUS-managed project was joined by 13 local and regional authorities from 17 member states, and a multidisciplinary expert panel.

The BRIDGE initiative served the purpose of developing a set of tools facilitating the detection and analysing local-level polarisation processes, in recognition of a broad array of indicators. A comprehensive audit comprised data and information regarding demographics, socio-structural inequalities, civic activity, protection factors, risk factors, and presence of polarising factors. It further included questionnaires concerning the presence of a zero-win attitude and "we/them" mentality, and an appraisal of networks and partnerships potentially helpful in combating polarisation. Basing on audit outcomes, EFUS supported local partners in drafting pilot projects meeting their needs, calculated to prevent polarisation and mitigate its outcomes.

During a debate planned for 30 June as part of the World Urban Forum, EFUS Programme manager Eszter Karacsony will present specific tools facilitating the detection and analysis of polarisation types and degrees at the local level, offer a brief comment on polarisation-related tensions potentially arising in the current war context, and list a number of sample methods and attitudes potentially contributing to the prevention of polarisation tensions and their abatement.
